-All student vehicles must have a parking pass clearly displayed in rearview mirror.

-Students are not permitted to access vehicle during sessions without permission.

-Please note that school functions (large conferences, SkillsUSA competitions, technology fairs) may cause a student's parking space to be unavailable throughout the school year. The Administration at BCAVTS will do their absolute best to announce these upcoming events and to find and announce alternate parking for students. Again, a student's parking space may be unavailable throughout the school year.

-Parking Permits are non-transferable.

PROCEDURE TO LEAVE THE PARKING LOT:

Students are NOT permitted to leave the parking lot until the buses have gone. The parking lot attendant will direct students when and how to leave the parking lot.
